Funds raised were used to continue development of the middle school, as well as operating costs for teachers, students and supplies. 10 classrooms and 4 blocks of student dorms have now been completed. Since 2010, 1,448 elementary and middle school students have been schooled, 83 of which have now graduated out to high school. Plus, a student health clinic is nearing completion on the property and has already been upgraded by local health authorities to be recognized as a "Medical Center" which will then be able to provide services to the surrounding community.

Donations were received for the construction of 1 more deep clean water well in one more village, which will be completed in 2025. Over 145,000 people now drink every day from our clean water wells.

4c (Code:) (Expenses \$ **24,750.** including grants of \$ **0.**) (Revenue \$ **0.**)
Raised charitable donations to provide additional Care Packages to 15 more families in Burkina Faso (with funds also being raised from within Burkino Faso itself for 35 families, totaling 379 families to-date, all of which have at least 12 people in each family) so they can grow enough food to feed themselves AND sell a surplus to fund their children's education.
